PARISH REGISTRATION

All families and individuals within the canonical bound areas of St. John the Evangelist are invited to register by contacting the Parish Office.

Adoration of the Blessed Sacrament: Adoration of the Blessed Sacrament takes place on Thursday from 8:30 AM to 4:00 PM in the Chapel. You are invited to visit as your schedule permits. If you wish to be a regularly scheduled adorer, please contact the Parish Office.

Sacrament of Baptism: The Sacrament of Baptism is celebrated on the First and Third Sunday of the month at 1:30 pm. Baptisms will not be performed during Lent. An instructional Infant Baptism Class is required for parents having their child baptized and is recommended for godparents. For more information and to register for Pre-baptism class, please call the Parish Office.

Sacrament of Marriage: Common Policy among the Dioceses in New Jersey recommends preparing for your wedding at least one year in advance. Please contact the Parish Office for more information.

Sacrament of Reconciliation: The Sacrament of Reconciliation is available every Saturday from 4:00-4:45 pm in the Reconciliation Room of the Church or by appointment.

Sacrament of the Sick: Please contact the Parish Office if you are homebound and would like to receive Holy Communion. In the event of an emergency, please call 732-685-1098, day or night.

Sponsor Eligibility: Godparents/Sponsor eligibility certificates are available for registered parishioners by calling the Parish Office. Godparents/Sponsors must be practicing Catholics who have received the Sacraments of Initiation and, if married, are in a marriage recognized by the Church.

WHOLE COMMUNITY CATECHESIS

Whole Community Catechesis is available for registered parish families with children in Grades 1-8. As the Primary Catechists of their children, parents are prepared and supported to lead their children in faith at home. Meetings are twice a month, one for Parents only to prepare for monthly activity lessons and one for parents and children to grow in community. Sacramental reception years (2nd and 8th grade) have additional Sunday meetings to prepare for receiving First Reconciliation/Holy Communion and Confirmation. The penitential season of Lent is upon us, and we Catholics, like Christians everywhere, begin preparing to commemorate the passion of Our Lord Jesus Christ. Lent is the forty-day liturgical season of fasting, special prayer and almsgiving in preparation for Easter. The name "Lent" is from the Middle English "Lencten," meaning spring; its more primitive name was the "forty days," "quadragesima" in Latin or "tessaracoste" in Greek. Lent begins this year on **Ash Wednesday, March 2.**

Lenten Fast and Abstinence Observance:

- Ash Wednesday and Good Friday are obligatory days of fasting and abstinence for Catholics.
- In addition, Fridays during Lent are obligatory days of abstinence.
- The norms on fasting are obligatory from age 18 until age 59. When fasting, a person is permitted to eat one full meal, as well as two smaller meals that together are not equal to a full meal.
- The norms concerning abstinence from meat are binding from age 14 onwards.
- If possible, the fast on Good Friday is continued until the Easter Vigil (on Holy Saturday night) as the "paschal fast" to honor the suffering and death of the Lord Jesus and to prepare ourselves to share more fully and to celebrate more readily his Resurrection.

The Mystery of Faith

After the priest has spoken the words of consecration over the bread and wine, and they have now become the Body and Blood of our Lord Jesus Christ, the priest genuflects in reverence and silent adoration before Christ's Blood. Then he rises and solemnly says, "The mystery of faith." This is an expression of awe and wonder for the mystery that has just taken place. Jesus Christ is physically present on the altar under the appearance of bread and wine.

Joining in the priest's expression of awe and wonder at the miracle that has just taken place we proclaim the story of salvation in one of three responses:

1. *"We proclaim your Death, O Lord, and profess your Resurrection until you come again."*
2. *"When we eat this bread and drink this Cup, we proclaim your Death, O Lord, until you come again."*
3. *"Save us, Savior of the world, for by your Cross and Resurrection you have set us free."*
